A Home and Hope

Restoration House brings hope to survivors of human trafficking through love, guidance, and the assurance of a long-term home.

Restoration House of Greater Kansas City provides long-term, comprehensive residential recovery services for women and girl survivors of human trafficking. R|H believes the healing and restoration process is a long-term endeavor and necessitates a steady and patient faith-based, trauma-informed process. As such, our numbers are impacted by the need to take 1 to 3 years to change a life that is empowered for long-term success.

In 2020, we had 653 requests for services by trafficking victims and we were able with God’s power to help some in truly miraculous ways. Yet we had to say no over 600 times for residential services.

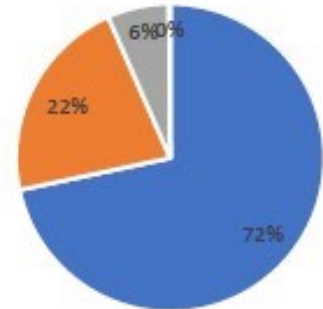

Revenue for Fiscal Year Ending 12/31/20



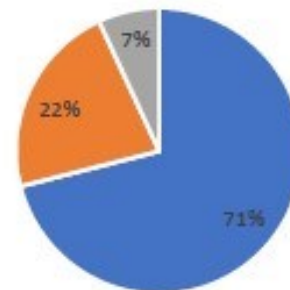
